



Photographic Waiver for Cobras Basketball Club

Photographic and Video Consent and Release

This document serves as a waiver and consent regarding the use of photographs and videos taken by Cobras Basketball Club, its representatives, employees, Ian Skelton Photography, or any other photographer requested by Cobras Basketball Club. This waiver applies to all participants involved in training sessions, matches, events, tournaments, or any other programs associated with Cobras Basketball Club.

Consent for Photography/Videography

By participating in any activities with Cobras Basketball Club, you acknowledge and agree that photographs and/or videos of you or your child may be taken by Cobras Basketball Club, its representatives, Ian Skelton Photography, or any other photographer requested by the club. These photographs and/or videos may be used for various purposes, including but not limited to:

- Posting on social media pages such as Instagram, Facebook, LinkedIn, or other platforms.
- Displaying on the Cobras Basketball Club website.
- Inclusion in marketing materials, such as brochures, posters, and advertisements.

It is understood that any professional photos taken of your child will be shared with you; however, ownership of these photos remains with Cobras Basketball Club. The club also ensures that these images will not be passed on to third parties without explicit consent.

Additionally, you acknowledge that other parents, guardians, spectators, or members of other basketball clubs attending games, training sessions, or tournaments may take photographs or videos of participants, including your child. Cobras Basketball Club is not responsible for the use or distribution of any images or videos captured by other spectators or basketball clubs.

Sharing of Photographs and Videos captured by yourself / or your child

If you, as a player, parent, guardian, or spectator, take photographs or videos that capture not only yourself/ your own child but also other participants, you agree to refrain from sharing these images or videos on social media or any other online platforms without obtaining consent from the player, their parents or guardians of the other participants who are visible in the images or videos. This is to ensure the privacy and consent rights of all individuals involved.

Release and Waiver

By allowing yourself or your child to be photographed or video recorded during participation in Cobras Basketball Club activities, you release, discharge, and agree to hold harmless Cobras Basketball Club, its officers, directors, employees, agents, representatives, Ian Skelton Photography, and any other photographer requested by Cobras Basketball Club from any and all claims, demands, rights, and causes of action of any kind that may arise out of or relate to the use of these photographs and/or videos. This includes, but is not limited to, any claims for defamation, invasion of privacy, or violation of publicity rights.

Participation in Cobras Basketball Club activities is voluntary, and by participating, you acknowledge and accept the use of photographic and video recording devices during these activities.

Ownership and Usage Rights

All photographs and videos taken by Cobras Basketball Club, its representatives, Ian Skelton Photography, or any other photographer requested by the club are the sole property of Cobras Basketball Club and/or the respective photographer. Cobras Basketball Club, Ian Skelton Photography, and any other photographer requested by the club have the right to edit, alter, copy, exhibit, publish, or distribute these photographs and videos for any lawful purpose. You waive the right to inspect or approve the finished product or any written copy that may be used in connection with the images.

Acknowledgment of Understanding

By participating in Cobras Basketball Club activities and allowing photographs and/or videos to be taken, you acknowledge that you have read, understood, and fully agree to the terms outlined in this document. You also confirm that you are providing this consent voluntarily and without any inducement.

If you do **not** agree to the terms of this waiver, the Cobras Basketball Club will take this as notification that you do not wish for yourself or your child to be photographed or video recorded. In this case, Cobras Basketball Club will make reasonable efforts to respect this request, including notifying coaches or representatives of other teams when there are players who do not have photographic consent. However, you acknowledge that Cobras Basketball Club cannot fully control or restrict other spectators from taking or sharing images or videos during public events.

This document now includes acknowledgment that other spectators, as well as members of other basketball clubs at games, tournaments, or training sessions, may take photos or videos. Additionally, it ensures that any images or videos captured by spectators that include other participants will not be shared publicly without proper consent, safeguarding the privacy and consent rights of all participants.
